DRUG & ALCOHOL SCREENING ACKNOWLEDGMENT

Drug & Alcohol screening is available as an intervention and part of treatment at Chat N Relax Counseling & Consultation, LLC <u>if applicable</u>. Drug & Alcohol screening will be random for those clients requiring testing to be part of his or her treatment plan.

Identify Diagnostics ® 12-Panel Drug Screening Cup will be used to collect the urine specimen for drug screening. Identify Diagnostics screening cup is a USA FDA approved test and cleared for professional use. Alcohol screening will involve but not limited to urine screening, test strips, and/or breathalyzer.

Drug & alcohol screening is only available for active clients and substance use evaluations. Drug and alcohol screening cup test is not covered by insurances. <u>The fee for drug and alcohol</u> <u>screening is \$20.00 per test</u>. In the event you (or youth) are/is selected for random screening, the fee may be paid during current session or due at your next session along with copay, coinsurance, etc. There will be no more than two (2) screenings a month if applicable.

Some drug & alcohol screening interventions will be monitored to minimize tampering.

For Male clients: DaRon Stephens, LPC, LCADC, LMT will monitor if applicable.

For Female clients: a certified and/or licensed female counselor/social worker colleague of DaRon Stephens, LPC, LCADC, LMT will be available to monitor if applicable.

Reasons for Drug & Alcohol Screening

<u>Reason 1:</u> Client and/or guardian voluntarily wants to be randomly screened throughout treatment for accountability.

Reason 2: DaRon Stephens, LPC, LCADC, LMT suspects recent use of drugs and/or alcohol.

Reason 3: Substance Use Evaluation Consultation

Reason 4: Accountability in regards into maintaining sobriety.

<u>Reason 5</u>: Part of treatment plan and/or recommendation of DaRon Stephens, LPC, LCADC, LMT.

A client and/or guardian may voluntarily refuse drug and alcohol screening however, if refused, it will be documented as a refusal in chart and follow up treatment recommendation will involve a higher level of care and/or termination from Chat N Relax Counseling & Consultation, LLC.

<u>For Alcohol:</u> If a breathalyzer test result is positive, you will be asked for your keys and your emergency contact will be contacted to come pick you up from office if driving. If you refuse to give up your keys or leave property, local police will be contacted.

All clients & or their guardian(s) are required to sign the Drug & Alcohol Screening Acknowledgment.
